The criteria for selecting the Consultants are:-

## **Minimum qualification requirements**

#### Mandatory

- Qualification from recognized tertiary institution preferable a Bachelor's Degree in environmental science, planning or similar, communication or public relations social management, or similar equivalent qualification.
- At least 2 years' experience in the assessment, management, mitigation, and reporting of environmental (biophysical) and social impacts/ risks and stakeholder's engagement.
- Experience conducting site inspections and compliance checks and have knowledge of managing social media, press releases and public statements.
- Language skills: Fluency in English and Kiribati and the ability to communicate effectively verbally and in writing.

#### Desirable

- 1-2 years' experience with donor-funded projects, especially projects involving international financial institutions such as the World Bank.
- 1-2 years of experience with the World Band and National Environmental processes and developing environmental and social instruments Oral and written Kiribati language skills. Knowledge of Kiribati cultural and customs.
- Experience in stakeholder and community consultation.
- Skills and experience in environment and social assessment.
- Knowledge and skills on basic GIS and field assessment tools and application such as Kobol Toolbox.
- Skills and experience with project management applications and software.
